## Previous Minutes

#### **Gravel Crusher**

- Cone liner replaced
- Welding on screen deck hoper completed, jaw hopper completed, grizzly resurfacing and repair completed
- Crushed 35,000 ton of ¾" e.g. at Lahrmann's pit
- Will be moving to Boyko's pit or Peter's pit

## Construction

RR 81 south of Twp Rd 553 straightening curves complete

## **Operations**

- Cutting Firewood
- Repairing signs
- Thawing some culverts
- Light grading in places, just pulling in edges not cutting heavy
- Rural addressing signs were discussed, having Administration investigating the same

## **Dust Control**

- Complaints on Haul Road Twp Rd 542 were reviewed Way's pit
- Complaints on Haul Road Lahrmann's pit calcium will be applied prior to road bans coming off. Administration informed the Committee of noise levels from the genset; it was consensus that Administration investigate different options.
- Calcium dust controls for residents will be applied on a designated schedule once per month

- County haul routes dust control will be applied in front of residences where designated
- It was the consensus of the Committee that road bans be applied on Monday, April 7, 2014. Farmers are being informed that they may utilized County roads, from their residences to the highway, closest possible routes.
- Hydro-axing will be undertaken when thawing is complete, having locations being provided to the Public Works Supervisor.
- Husky Energy has submitted a request for stop signs at the intersection of Twp Rd 532 and RR 75, having the same being investigated by the Public Works Supervisor.
- Correspondence was received from the Village of Willingdon for quotes, having Administration providing quotes for the same.
- Correspondence was received from the Town of Two Hills regarding reclaiming within the Town of Two Hills. It was the consensus of the Committee that the County reclaim the requested 26,300 m2 at one time (weather permitting).
- It was the consensus of the Committee that Administration seek legal advice regarding paving in front of residences and applying the same to the taxes.
- It was the consensus of the Committee that paving of 400 feet in front of a residence will be 50% (approximately \$5,000), limited to 2 residences per division per year.
