Gravel Crusher

- Cone liner replaced; put heavy liner (for coarse)
- Crushed 80,000 ton of ¾ inch E.G at Lahrmann's; will be crushing an additional 10,000 tons
- Will be moving to Boyko's pit or Peter's pit
- Running one shift
- Boschman's checked – yield 15,000 to 20,000; no other finds; McMahon's to check

Construction

- Rip and relay on sections of Twp 540 east of Hwy 41 – 3 sections
- Rip and relay Twp 551 A east of RR 65 – 1 mile; trail around the lakes
- Rip and relay RR 63 portions north of Hwy 640
- Discuss Road Building season – RR 113 and RR 75

Operations

- Stockpiling gravel at Two Hills Main Shop Yard (20,000 ton) and Willingdon Shop Yard; 70 requests for deliveries
- Clearing and steaming culverts on grid roads
- Sign repair and replacement
- Installing Rural Addressing signs
- Repairing water leak Derwent
- Thawing sewer lines, 3 separate occasions
- Thawing water lines Derwent, 3 occasions
- Road grading complete pass to begin now that rainfall has stopped

- 1 Caterpillar 272 bobcat with 6 way angling broom and post haul auger

General Items

- Request to name Twp 552 west of Highway 41 as Angle Lake Road. It was the consensus of the Committee to defer this item to the March 12, 2014 Council Meeting.
- Request for cleanup of an unsightly property in the Hamlet of Hairy Hill. It was the consensus of the Committee to defer this item to the March 12, 2014 Council Meeting.
- Request for repair of fence damaged by snow removal on SE-12-56-12-W4, NE-12-56-12-W4 and SW-7-56-11-W4. The Committee reaffirmed to not repair fence damage due to snow removal.
- Request for paving of Twp 562 from the intersection of RR 115 to the gate of Tranquility Bay. The Committee reaffirmed that paving will not be done on private land.
- Request for lighting at Sandy Lake bins. It was the consensus of the Committee that R. Bouchard, Public Works Supervisor be authorized to obtain an estimate for the same from Atco Electric.
