BYLAW & POLICY:

Bylaw No. 11-2022: Council duly enacted Bylaw No. 11-2022 Fire Services being a Bylaw of the County of Two Hills No. 21 for the purposes of establishing Fire Protection Services and the Recovery of Fire Protection Service Costs being permitted and non permitted.

Bylaw No 03-2023: Bylaw No. 03-2023 being a Bylaw of the County of Two Hills that repeals and replaces Bylaw No. 08-2021 Schedule of Fees – Schedule 'A' to increase Jackfish Lake Gazebo rental to \$150.00 per day. Also, it was resolved that the County of Two Hills sale of Tax Certificates and Assessment Sheets increase to \$30.00, effective January 1, 2023. At the January 23, 2023 Regular Council Meeting, it was resolved that the County of Two Hills agreed to a \$0.10 increase on ACE Water billing for the Hamlet of Derwent effective January 1, 2023.

SNOW PLOWING



With the onset of winter, the Public Works Department would like to remind residents that the snow plowing of driveways will be available to full-time residents that qualify.

As part of the snow clearing policy: **BUS ROUTES AS WELL AS HOME CARE WILL BE GIVEN FIRST PRIORITY FOLLOWED BY COUNTY ROADS AND DRIVEWAYS,** so please be patient as the Snow Clearing Crew will do their best to reach qualifying residents in a timely manner. Further, snow flags will no longer be required.

- Seniors \$100 per year
- Full Time Residents \$250 per annum on November 1 and onward
- Custom Snow Plowing flat fee of \$200, additional hours as per Fees Schedule.
- Home Care and Bus Turnarounds no charge.
- Fees do not change if there is abundant snow or no snow.

Lastly, due to safety concerns, the County of Two Hills asks residents to fully clear County roads of residual snow left when clearing driveways and piling into ditches. Leaving the two ridges is a driving hazard and if an accident occurs the landowner is liable.
