

AGRICULTURAL SERVICE BOARD

ROADSIDE SPRAYING PROGRAM

The County of Two Hills Agricultural Service Board will be starting their Roadside Spraying Program along municipal roads, as required, to control the spread of weeds and brush.

Landowners who do not want the ditches adjacent to their property sprayed can sign an ANNUAL "NO SPRAY AGREEMENT" stating that the landowner accepts responsibility for the control of weeds in the ditch along the property, having County No Spray Signs issued. lt is the landowner's responsibility to ensure that the No Spray Signs are in place and clearly visible during the entire 2023 Spray Season (to commence mid July, 2023). If the landowner fails to control the ditch, the County shall exercise control by means appropriate. For more considered information, or to sign a "No Spray Agreement" contact: 780-657-3358.

ROADSIDE MOWING PROGRAM

Please be advised that persons wishing to cut hay on road allowances, agricultural ditch cutting must be completed prior to August 1 of each calendar year. The County of Two Hills Roadside Mowing Program along municipal roads will begin Monday **August 2, 2023 in Division 4 & 5**. All standing grass will be cut with no exceptions, swaths will be respected. Questions or concerns may be directed to the ASB Department at 780-657-3358.

NATURAL GAS UTILITY SECONDARY GAS LINE REGULATIONS

Reminder, prior to the sale or installation of any secondary gas line, a gas permit is required.
