WHEREAS the estimated expenditure for the County of Two Hills No. 21 adopted budget for the year 2021 is \$17,389,080 and,

WHEREAS the Total Assessed Value of Taxable Property within the County of Two Hills No. 21 as shown by the assessment roll is as follows:
