# Hamlet of Derwent

The CAO informed Council three representatives from ATCO Electricity Service had met to discuss the Hamlet of Derwent Franchise Renewal. The current ten year franchise agreement expires July 28, 2018.

ATCO has 84 Franchise Agreements in place for electricity service.

- The Hamlet of Derwent currently has a 6% franchise fee.
- The Hamlet of Willingdon currently has a 2% franchise fee, renewed in the Village in 2017.
- The County of Two Hills has a zero percent franchise fee.
