The same correspondence informs that the Ministry is implementing a three-year tax incentive on new wells and pipeline assets having these properties receive an assessment of zero, the Well Drilling Equipment Tax will be eliminated in January 2021, having depreciation adjustments provided for lower-producing wells and, a shallow gas assessment reduction of 35% for three-years.
