Tax Exemption (Roll No. 496400 & 496500)

The CAO informed that the County received correspondence from the Ukrainian Greek Orthodox Church of St. Mary (Szypenitz) requesting that the portions of NW 22-55-13-W4 (E ½ North of Lake, Roll No. 496500) and NW 22-55-13-W4 (W ½ North of Lake, Roll No. 496400), all those portions assessed as farmland, be tax exempt. The Ukrainian Greek Orthodox Church of St. Mary (Szypenitz) lands have been designated as a historical site in both Alberta and Canada.

Bylaw No. 4-2025

G. Buchanan presented Bylaw No. 4-2025 informing Council that W. Wiebe is proposing, via the Blumenthal Area Structure Plan (ASP 1 2025), to construct a multi-lot subdivision on NW-24-55-12-W4. In parallel to the review and adoption of the rezoning (Bylaw 5-2025) and prior to the approval of the proposed subdivision, the Area Structure Plan must be adopted.

The ASP proposal is for 12 residential lots, 1 Municipal Reserve Lot and 1 Environmental Reserve Lot. These lots would be accessed by an internal road linking Range Road 121 to Township Road 554.

The ASP proposal is for 12 residential lots, 1 Municipal Reserve Lot and 1 Environmental Reserve Lot. These lots would be accessed by an internal road linking Range Road 121 to Township Road 554. All lots would have on site cisterns for water supply and holding tanks for sewage disposal, enforced by a restrictive covenant one each title. The required internal road would be constructed to County standards.
